 - b. clean up and reorganize should allow plenty of space
 - c. has materials to build shelves if necessary
 - 4. do the racks in the storage belong to WECC?
 - a. yes, 3 shelves at storage and 1 at Dave's house
 - b. Mike has 2 sets of keys for storage
 - c. Dave still has a number of items that need to be transferred yet
 - d. Nick will be available tomorrow evening to accept storage items
 - 1. Nick has pick-up that would be easier for transport
 - e. should we wait until social distancing parameters lifted?
 - 5. Danielle's biggest concern is getting materials back from Dawn
 - C. State Tournament
 - 1. now online via chesskid.com on May 2[,] 2020
 - 2. no qualification necessary

- b. seven rounds to allow for lack of accelerated pairings
- 4. Danielle says wording on website really confusing
 - a. Edith provided feedback to tournament organizers
 - 1. entertaining to see her exact wording appear on website

a. identifying regions for trophy dropoff for individuals to handle distribution

- 6. offering full refunds until April 20th
 - a. Edith made sure to hear from coaches concerning these players
- 7. how to prevent cheating?
 - a. organizers said chesskid.com has extensive anti-cheating system
 1. dedicated staff member to analyze possible cheating moments to be addressed after the fact
 - b. what about a family member helping player?
 - 1. generally assume most players will be honest
 - 2. comparable to someone going to the bathroom and
 - referencing a device
- C. 2020-21 Tentative Schedule
 - 1. Danielle leaning toward not doing Amon Creek Castle 11/07
 - a. hasn't thought much about it, but spoke briefly with co-coach
 - 2. Danielle ran down the schedule
 - a. PSD tournaments set according to Edith
 - b. minor changes
 - 1. McLoughlin to Ochoa
 - 2. December 19th to December 12th

3. if Tri-City Prep takes Amon Creek spot, season ends after Bishop Battle Star

- 4. State tournament in Spokane on April 24th
- 5. Dave sending out tentative schedule
 - a. annual numbers often incorrect
 - b. years at top also wrong
- 6. Danielle shared screen to address changes to tentative schedule
 - a. got rid of all Roman numerals except for RRR (oldest one)
 - b. PSD tournaments now K-8
 - c. Danielle will have an answer for Amon Creek at next meeting
- 5. New Business
 - A. submit the change of board members to Secretary of State
 - 1. Mike took care of it last year
 - 2. Dave would really like to get new names to SOS
 - a. does not want to be associated with board any longer
 - 3. do need signed meeting minutes to demonstrate changes
 - 4. Mike will take these minutes to take care of this
 - a. once minutes are approved at next meeting in May
 - B. visit HAPO to change signature authority
 - 1. should be the same rigamarole
 - a. everyone will need to re-sign
 - 2. cannot do this until stay at home directive is lifted
 - a. they currently cannot open their lobbies
 - b. a month out at least
 - c. dependent on approved minutes

- 3. may allow this electronically during pandemic
 - a. in past encounters they seem hesitant about scams
- 4. Mike has checkbooks
 - a. handed over from Dave
- C. Summer Chess Nights at Richland Public Library
 - 1. Danielle would like to get the ball rolling, to plan ahead
 - a. need to be flexible
 - b. may need to also space players out
 - 2. Alex mentioned that 2 main coaches—Dave and Stan—no longer part of WECC

a. Doug led 4 of 6 lessons last Summer

- 1. gone for family vacation last 2 weeks
- b. Alex suggested that Doug would be responsible for all 6
- Doug commented on room reservation at Richland Public Library

 RPL contact told him Gallery is already booked for entire sixweek period
 - 1. did not respond to inquiry about STEAMSpace
- 4. attendance varies dramatically week to week

a. starts strong and tapers off

- 5. if social distancing is still required, not sure how we could pull it off a. whatever the plan is to reopen things will likely still involve social distancing
- 6. Alex mentioned the possibility of doing something online
 - a. Jeff said that his son tried doing something on chesskid.com for school club and it was pretty clunky
- 7. Doug will continue to ask about room reservation at RPL
- 8. Danielle suggested moving to Mid-Columbia Libraries if RPL doesn't allow for 6 consecutive weeks
 - a. would likely need to use meeting room at Kennewick Library
 - b. traditionally held at RPL but not necessary
 - 1. Danielle reiterates need for flexibility
- D. purchase new black WECC shirts
 - 1. ladies fit, suited for golf, different material
 - 2. Danielle doesn't feel this is terribly urgent
 - 3. Mike says we need to get shirts to new board members
 - 4. Dave gave last shirt out that he had from previous order
 - 5. Danielle will investigate options and pricing for shirts
 - a. report back next meeting
