- 2. Mike has 2 sets of keys for storage
 - a. can pass on a set to whoever wants them when the time comes
- 3. Mike still has supplies that we sell
- 4. Nick offered storage space
 - a. where is this?
 - b. we can wait to hear more details before we decide

C. WSECC

- 1. 1100 players
- 2. 55 players investigated for cheating
- 3. warm-up event the Saturday before
 - a. Edith experienced issues with multiple devices
 - 1. solved image issue with school district
 - 2. administrator claimed technical difficulties related to
 - personal devices
- 4. day of tournament, server crashed @ 9:20 am
 - a. had to restart at 10:30 am
 - 1. made for a very long day
 - b. Zoom meeting set up to address problems as they arose
 - 1. not ideal considering ages of players
- 5. a worthwhile attempt, but largely problematic
- 6. first move 30-second rule potentially led to disqualifications? a. also issues with bathroom breaks
- 7. a lot of skip issues
 - a. players missing whole rounds
- 8. offered refunds depending on when they were kicked out
 - a. full refunds if appropriate
 - b. \$5 less if players wanted a participation medal
 - 1. Edith said do this for any player with her email
- 9. players' level of play varied from round to round
 - a. suspected help from adults
 - b. frustrated any number of participants
 - c. a lot of work to review/investigate potential cheating
- 10. used chesskid.com because they had kid-friendly privacy in place
 - a. many people suggested chess.com would have been better
 - 1. Alex suggested that rating system utilized by the latter may have also influenced the decision

1. monitor the ongoing games

2. how to accommodate players without computers?

a. school districts trying to get Chromebooks home

to students, rushing purchasing to reach 1:1

b. begs the question of home wi-fi issues

1. PSD provided specific devices to make

allowances for this

g. would online platform allow for pairings?

1. not suited to current pairings available

a. makes it challenging to start

2. doesn't account for school/team pairings

a. SwissSys has setting to avoid these

- 4. Danielle suggests we push out Summer chess classes until we know

more

- a. possibly move to August
- b. each of us can consider alternatives/adjustments to make them safer for players
- c. table for June
- d. means to advertise Summer lessons also compromised
 - 1. school Facebook pages instead
 - 2. lunch pick-up sites

G. new black WECC polos

- 1. what happened to all of our polos?
 - a. given to volunteers as needed

2. what about using a nametag sticker with WECC logo for daily ondemand volunteers?

3. \$15.00 about the cheapest we can get for polos

- a. similar to the ones we currently use
- 4. better quality runs \$20+
- 5. customink.com, minimum order typically 6
- 6. do we want to look at t-shirts?
 - a. less expensive
 - b. varies on quality of these
 - 1. \$9.65/ea, no minimum amount
 - 2. about half the price of polos
 - 3. could use larger size logo on a t-shirt

a. can go bigger on polos as well, since they no longer have front pocket

- 4. people associated with organization could receive nicer
- polo/shirt, including board members and regular

coaches/volunteers, whereas we could have t-shirts on hand for occasional, day-of volunteers

a. makes a more formal distinction for

parents/coaches to determine who better to talk to

7. do we want polos to feature officer title?

a. additional expense, but also too variable

b. maybe we could get nicer official, nametags for officers

1. elevates credibility, identifies board members involved with organization of tournament

- c. polos/shirts also to feature "VOLUNTEER"?
- 8. Danielle will look into the following for next meeting

- b. polos for regular volunteers
 - 1. cotton or jersey?
 - a. 100% cotton
